## HELPING OUR VETS LIVE INDEPENDENTLY

I ask for your help to spread word about a free VA program that helps keep veterans living at home if they need assistance with "activities of daily life." Independence is the goal.

It is called "Veteran Directed Care" a terrific program from VA that is free to any veteran based only on need for help living independently; it is in addition to any other VA or military benefit and is tax-free. No requirement for a VA disability rating, and it is not incomebased...all VA wants is to help vets continue living at home as long as that is their wish.



#### QUALIFICATIONS

### VETERAN DIRECTED CARE:

- Veteran must be enrolled, or get enrolled, in VA healthcare
- Veteran must need assistance with two or more "activities of daily life" (ADL)
- Veteran must have referral from local VA social worker
- Care can be provided by family members, friends or commercial services
- Veteran is given a budget calculated by VA to address ADL needs; self-directed then
- General rule of thumb: if a veteran would be in a nursing home except for help from the family, that's the right veteran for Veteran Directed Care

### Vets' Favorite VA Benefit After Compensation & Medical Care

That's right! Vets already in this program rate its importance to them just behind compensation and medical care itself. This new and truly phenomenal VA program is called Veteran-Directed Care (VDC.) Veterans' organizations worked with Congress and elder care experts to create a special benefit design to serve vets of all ages who want to live independently.

Why? Because VDC helps veterans who need help from others to live at home. We wanted VDC to help all vets living at home (and their families!) when otherwise a veteran might be forced to make an assisted living or nursing home decision.

VCD helps veterans get and pay for in-home care if experiencing one or more "activities of daily life" (ADL) problems. Often, when ADLs are difficult a veteran is faced with the need to finally seek assisted living or even a nursing home. Neither the VA nor the veteran want that day to come any sooner than necessary.

Thus Veteran Directed Care. The reason veterans and families in dozens of VA regions nationwide embrace VDC is the help it delivers resolving a veteran's difficulties of hygiene, transportation, housecleaning, yard work and snow removal, companionship, home health care and so many other ADLs. Perhaps these needs are being met by family members' loving care, (however difficult) or at family expense by hiring assistance from care providers or commercial services.

To help continue living at home, VA will help address these ADL issues at VA expense, exactly as directed by the veteran. Thus the name Veteran-Directed Care, because it is the veteran's choices that are observed as important needs are met.

#### WHY YOUR HELP?

- •VA doesn't seem to actively promote this program: Word of mouth does more to enroll veterans. You know other veterans and their needs (and their families'.) They need for a word from you about VDC
- •If you see a veteran who but for help from a spouse or family member would need assisted living or a nursing home, that veteran is likely to benefit. Typically a VDC vet is older but **every** vet needing help can participate in the benefit.
- •Have the veteran or family member contact a VA social worker at the local VA clinic or hospital. A VA primary care provider can also get the wheels turning for the vet's needs to be assessed. VA contracts with local non-profit or government agencies to get a budget set up to get financial help to keep living at home.

Veteran-Directed Home and Community Based Services gives Veterans of all ages the opportunity to receive the Home and Community Based Services they need in a consumer-directed way.

#### VA STATEMENT ON VETERAN DIRECTED CARE:



The Veteran Directed Care Program (VDC, formerly VD-HCBS) gives Veterans of all ages who are at a nursing home level of care the opportunity to live at home and direct their care and services. In VDC, Veterans are given a flexible budget for services that can be managed by the Veteran or the family caregiver. Veterans decide what mix of services will best meet their needs; hire their own personal care aides (which might include family members, friends or neighbors); and buy items and services that will help them live independently in the community. Services and products must be unavailable from the VA itself. For instance, wheelchairs can be prescribed by VA and thus, not purchased under VDC. Chair lifts, however, are not provided by VA and can be budgeted with VDC.

As part of this program, Veterans and their caregivers have more access, choice and control over their home care services or long-term care services. Caregivers of Veterans may find this program helpful because the Veteran can customize their care to fit their life, hire family, friends and neighbors to provide care and services, and support their family caregivers through consumer-directed respite and other caregiver support services.

#### PLEASE CONSIDER:

- If you know an elderly veteran in any way dependent on family care, that vet is likely to benefit from VDC
- Elderly veterans with elderly companions are very likely to benefit as VDC services, like housekeeping and yard work, help both live independently.
- Veterans living alone might be especially helped with VDC, considering the safety factor of having outside involvement and by assisting with difficult chores like snow removal, gutter cleaning and lawn care, activities where falls are a risk
- Please take a few minutes to consider a few minutes to think of a vet who might benefit from this program...or a family struggling to care for their vet who needs help to continue living independently instead of in a nursing home.

VDC is a fantastic program of service to all our veterans, their families and our community. Advocates have worked hard with Congress and VA, the goal being nationwide coverage. We're almost there!

VDC provides a budget for veterans enrolled in VA health care for help to live independently, avoiding nursing homes or assisted living solutions whenever possible. The program is not income-based and is offered to all, regardless of income high or low, who have an honorable discharge or commission. Veteran Directed Care is tax-free help to keep living at home,

VDC is in addition to any other benefit a veteran may have. Veterans don't need a VA disability rating to qualify...only the need for help to live independently to avoid or postpone a nursing home decision. What services have veterans received through VDC? Lawn care, snow removal, general yard cleanup, gutter cleaning, housekeeper, meal prep, meal deliveries, medication supervision, transportation, general handyman, power chair lift, home healthcare aide and more.

Our community benefits as well. Services are provided veterans at no expense to the veteran or charitable community services. Veterans get assistance they might otherwise have missed or not afforded, such as snow removal or meal preparation. Veterans can use their VDC budget to hire family members to provide necessary care, or to pay for outside help
