Reimbursement for Emergency Treatment

AGENCY: Department of Veterans Affairs

ACTION: Interim final rule

SUMMARY: The Department of Veterans Affairs (VA) revises its regulations concerning payment or reimbursement for emergency treatment for non-service-connected conditions at non-VA facilities to implement the requirements of a recent court decision. Specifically, this rulemaking expands eligibility for payment or reimbursement to include veterans who receive partial payment from a health-plan contract for non-VA emergency treatment and establishes a corresponding reimbursement methodology. This rulemaking also expands the eligibility criteria for veterans to receive payment or reimbursement for emergency transportation associated with the emergency treatment, in order to ensure that veterans are adequately covered when emergency transportation is a necessary part of their non-VA emergency treatment.

DATES:

Effective Date: This rule is effective on January 9, 2018.

Comment Date: Comments must be received on or before March 12, 2018.

In addition, during the comment period, comments may be viewed online through the Federal Docket Management System (FDMS) at http://www.regulations.gov.

SUPPLEMENTARY INFORMATION: 38 U.S.C. 1725 authorizes VA to reimburse veterans for the reasonable value of emergency treatment for non-service connected conditions furnished in a non-VA facility, if certain criteria are met. One requirement is that the veteran must be personally liable for the emergency treatment. As originally enacted in 1999, the statute provided that a veteran is personally liable if the veteran ``has no entitlement to care or services under a health-plan contract," and ``no other contractual or legal recourse against a third party that would, in part or in whole, extinguish such liability

to the provider." 38 U.S.C. 1725(b)(3)(B) and (C) (1999). VA interpreted that version of the statute as barring reimbursement for veterans with any coverage from either a health-plan contract or a third party because those veterans did not satisfy the requirement to have ``no entitlement . . . under a health-plan contract" and ``no other . . . recourse against a third party."

Cremains Project Report

As of today we are currently working on 35 active eligible remains. Of the original 43, 8 have been picked up by family members.

We were honored to have Tom Phillips of G Street Productions show an interest in our work and create a documentary for the Vietnam Veterans Memorial Foundation. The finished product was released last month.

On December 13, 2017 our Cremains Committee gave a presentation about our program to the VFW 2179 Auxiliary. We also debuted our new video and it was well received.

Also on December 13, Dan Higgins and I met with Cyndi Dzurisin at DMAVA to deliver 5 applications and to discuss the possibility of our ceremonies including more than 8 cremains. We have agreed that we can increase the number of cremains for our ceremony to about 15 but they would have to be interred over a 3 day period as manpower allowed.

Received an interest in the Cremains Project from Maynard Kaderlik of the Minnesota State VVA Council as a result of our video. They are interested in starting a program similar to ours in Minnesota.

Income Tax Exemption for Veterans

New for Tax Year 2017. You are eligible for a \$3,000 exemption on your Income Tax return if you are a military veteran who was honorably discharged or released under honorable circumstances from active duty in the Armed Forces of the United States by the last day of the tax year. Your spouse (or civil union partner) is also eligi ble for an exemption if he/she is a veteran who was honorably discharged or released under honorable circumstances and you are filing a joint return. This exemption is in addition to any other exemptions you are entitled to claim and is available on both the resident and nonresident returns. You cannot claim this exemption for a domestic partner or for your dependents.

Providing Documentation

You must provide a copy of Form DD-214, Certificate of Release or Discharge from Active Duty, the first time you claim the exemption. **This form does not need to be provided each year.** The <u>United States National Archives and Records Administration</u> can assist with obtaining a copy of your DD-214.

You can certify for the exemption by sending a copy of your DD-214 and <u>Veteran Exemption</u> <u>Submission Form</u> to the Division **before** you file, which may help process your return faster. To certify:

Mail a copy of your DD-214 and <u>Veteran Exemption Submission Form</u> to: The New Jersey Division of Taxation, Veteran Exemption, PO Box 440, Trenton, NJ 08646-0440; or Fax your DD-214 and <u>Veteran Exemption Submission Form</u> to 609-633-8427.

If you do not certify before you file for the exemption, you will need to submit a copy of your

- DD-214 when you file using:
- *A Paper Return.* Enclose a copy of your DD-214 with your return;
- NJ Fill'nFile. Upload your DD-214, along with all of your other documentation, into the repository;
- Other Electronic Filing Methods. If you file your return using NJ WebFile, third-party software (such as TurboTax), or you have a tax professional who electronically submits your return, you can send a copy of your DD-214 and <u>Veteran Exemption Submission Form</u>using one of the three certification methods listed above.

New Online Tool Will Provide Veterans With Customized Instructions for Discharge Upgrade Process

WASHINGTON — The Department of Defense (DOD), through a joint initiative with the U.S. Department of Veterans Affairs (VA), has launched a new <u>web-based tool</u> that will provide customized guidance to Veterans who desire to upgrade or change the conditions of their military discharge. By answering a few short questions, Veterans will receive information on the specific armed services board to contact, the form/s to fill out, special guidance applicable to their case, where to send their application and helpful tips for appealing their discharge.

"This new tool and partnership with DOD is one of many VA initiatives offered to Veterans who believe they may have been unfairly discharged or received an unfair discharge characterization," said VA Secretary Dr. David J. Shulkin. "Veterans who believe their discharge was unjust, erroneous or warrants an upgrade are encouraged to use the tool and then apply for review."

DOD officials also praised the new innovative tool.

"We are thrilled to have partnered with the Department of Veterans Affairs in developing this wonderful and easily accessible tool," said Mr. Robert Wilkie, Under Secretary of Defense for Personnel and Readiness. "We support our Veterans, whether they served recently or long ago, and we are excited to introduce a tool that will individualize the guidance for those who desire an upgrade or change in their military discharge."

The military has estimated that tens of thousands of Veterans with less than honorable discharges are especially likely to have unjust discharges deserving of upgrades. These are Veterans who were discharged due to incidents relating to post-traumatic stress disorder, traumatic brain injury or sexual orientation. Fragmented and confusing information has historically deterred Veterans from obtaining crucial information and — in many cases — necessary benefits.

From "Robert E. McNulty, Sr." VVA State Council: Proposed DMAVA Split

I was originally working on the basis of the DMAVA split proposal being proposed in October 2017. Turns out is was first proposed in July 2016. That begs the question as to why during all that time no one saw fit to reach out to the veteran community for our input. Here is some info for your review going forward.

I have been communicating with a staff member of the 1st lady and a policy advisor to the Governor's transition effort. I have reviewed some of the statements from Col. Cantor, both written and spoken. I spoke with the Colonel personally.

Regardless of how one describes what I have heard, using terms such as but not limited to, a proclivity for lying, verbal larceny, truth shading or prevaricating, we as veterans deserve better. George Costanza famously said, "It's not a lie if you believe it." That is not where I am however.

What is the impetus for suggesting such a change? It was clear back in 2016 who was behind this, however when I inquired no one wanted to take ownership of the proposal.

No cost estimates for increased manpower and office space. This would seem to be a first step requirement.

No breakdown as to how many new positions would be created. This too should be established before launching any changes.

Where would additional offices be located? Is the requisite space available?

What would be the extent of splitting shared services? What stays and what goes?

What timetable would this change involve? When would it start and when would the changes take effect? Will there be a major disruption of services?

With the budget set until June 30, 2018, from where would the required funding be derived? Will existing programs be short-changed to provide the needed funding for the proposed changes?

Now many of us in the veteran community fully appreciate that the new positions are subject to the incoming Governor's discretion. Having said that, we would like to be assured the individuals being selected have experience interacting with the veteran community. That has not always been the case in the past and we would like to think that we do not revert back to patronage jobs for ill-qualified individuals. The veteran community has a vested interest in the success of the Department of Military and Veterans Affairs and we have partnered with DMAVA in a successful manner that we would like to continue.

VA Announces Rollout and Application Process for New Veterans ID Card

--- Today the U.S. Department of Veterans Affairs (VA) announced that the application process for the national Veterans Identification Card (VIC) is now available for Veterans --yet another action honoring their service.

This has been mandated through legislation since 2015 to honor Veterans, and today's rollout of the ID card fulfills that overdue promise.

Only those Veterans with honorable service will be able to apply for the ID card, which will provide proof of military service, and may be accepted by retailers in lieu of the standard DD-214 form to obtain promotional discounts and other services where offered to Veterans.

"The new Veterans Identification Card provides a safer and more convenient and efficient way for most Veterans to show proof of service," said VA Secretary Dr. David J. Shulkin. "With the card, Veterans with honorable service to our nation will no longer need to carry around their paper DD-214s to obtain Veteran discounts and other services."

The VIC provides a more portable and secure alternative for those who served the minimum obligated time in service, but did not meet the retirement or medical discharge threshold. Veterans who served in the armed forces, including the reserve components, and who have a discharge of honorable or general (under honorable conditions) can request a VIC.

To request a VIC, Veterans must visit <u>vets.gov</u>, click on "Apply for Printed Veteran ID Card " on the bottom left of the page and sign in or create an account.

Veterans who apply for a card should receive it within 60 days and can check delivery status of their cards at <u>vets.gov</u>. A digital version of the VIC will be available online by mid-December.

ELECTION NOTICE

As required by the Constitution and By Laws of Vietnam Veterans of America, the New Jersey State Council, and VVA Chapter 12, this is notice that the Annual Election of Officers, Board of Directors, Nominations Committee, and State Council Delegates will take place at the Annual Meeting of Chapter 12 on Wednesday, April 4, 2018, which meeting will commence at 7:30 P.M.

The Offices of President, 1st Vice President, 2nd Vice President, Secretary, and Treasurer are for a term of one (1) year. "Play HOOK-e" From PTSD By Greg Kucharewski HANGAR LZ-64 IS HELPING PTSD VETS

What is hangar LZ-64? It's a place for veterans with PTSD to interact with one another, experience aviation opportunities and get connected with the outdoors. Veterans can participate in healthy outdoor activities and also learn new hobbies that help them "Play HOOK-e" from PTSD. It's like taking a mini-vacation from PTSD. Let's face it, PTSD symptoms never really go away. Medications offer some relief and help control episodes but it's really up to the person with PTSD to look for other solutions that can offer relief as part of a proactive approach to their overall health.

I received some documents about coping with PTSD from Joe Leone, VVA Chapter 12 PTSD Committee, that stated the following: Assisted Psychotherapy for PTSD - Animal assisted therapy including therapy dogs and the Equine Therapy has shown evidence based efficacy in patients including war veterans with PTSD, depression, anxiety, attention-deficit/hyperactivity disorder, dissociative disorders, and other chronic illnesses. Practice relaxation exercises - muscle relaxation, breathing exercises, meditation, prayer, outdoor physical exercise such as walking, running, swimming, fishing, scuba diving, and yoga are all very helpful. Volunteering your time to a worthwhile charity, veteran organization or hospital can be very helpful. As you know, Joe provides a lot of information about PTSD health updates at our VVA Chapter 12 meetings and his volunteerism has helped him too.

Eco-therapy (exposure to nature and the outdoors) also helps limit PTSD symptoms. If you are able to get outside daily or focus on a hobby such as fishing and exploring new activities that bring you closer to nature, eco-therapy might be an option for you. We can connect you to free programs for PTSD veterans. LZ-64 and Vietnam Veterans of America Shore Area Chapter 12 is all about sharing information, teaming up, volunteering, getting well, and having fun outdoors. You can learn more by attending a VVA Chapter 12 meeting or registering at a "Play HOOK-e" from PTSD LZ -64 gathering. Remember we are here to help you, all these positive coping methods and activities takes practice like any other skill. Come out and join us, take your time and don't be discouraged.

During January, Steve Biggar, Pilot & Paws and Don Davison, VVA12 volunteered to help bring 7 puppies and their mother from Federick, Maryland via small aircraft. The purpose of the trip was to bring the mother and pups to New Jersey families that adopted the dogs and will give them a safe home. Fallen, But Not Forgotten: Search and Recovery of MIAs

The **presentation** will provide an update on the Nation's search and recovery operations to bring home the skeletal remains of those service members who remain "unaccounted for" from Southeast Asia, Korea and World War II.

Through the use of colored slides, the audience will be able to see actual recovery missions, and will be exposed to some of the scientific processes (including DNA) used to identify the recovered remains and return them to the service member's family. Included in the presentation will be an update on recovery missions into North Korea (Democratic People's Republic of Korea) and a very significant recovery of WWII Marines from the South Pacific.

There are more than 1,600 service members who remain "unaccounted for" from Southeast Asia; almost 7,700 from the Korean War; and almost 73,000 from WWII. The audience will gain an understanding and appreciation for our Nation's commitment and the dedication of the soldiers and civilians who conduct this arduous duty to achieve the fullest possible accounting.

Invitation for Vietnam Veterans Monument Dedication in Barnegat

You are cordially invited to the dedication ceremony of Barnegat, NJ's monument for Vietnam veterans. Our invitation is also extended to anyone you think would be interested in showing support for our Vietnam veterans.

Perhaps the first Vietnam veterans monument in the country to be paid for completely by a Vietnamese refugee individual and her husband and not an organization or group, our hope is for other towns and communities across America to be inspired by this, and to do the same for their own Vietnam veterans. No donations towards this monument have been or will be accepted.

As a Vietnamese refugee who escaped Saigon on April 30, 1975, I recently founded a movement in our town of Barnegat, NJ, that focuses on thanking Vietnam veterans in our community in 2 ways - by building a monument for our town's Vietnam veterans, and by hosting a recurring series of "Thank You" dinners for small groups of Vietnam veterans in our town (also funded completely by me and my husband), until we're able to reach and thank all of them.

The monument is currently being built, with the dedication ceremony happening on the 1st nationally recognized Vietnam Veterans Day, which is Thursday, March 29, 2018. The dedication ceremony will occur at 12 noon at Barnegat's Gazebo Park (Rte 9 and West Bay Ave), with a celebration immediately following that will be hosted by and at the Barnegat American Legion Post # 232. All are welcome.

We would love for as many people to attend as possible, to show our Vietnam veterans how much they're supported and appreciated. They are the true VIPs of our event, although we are hoping to get guests from very high positions to underscore the intent of showing our Vietnam vets how special they are. We already have some high dignitaries from political positions and veterans groups attending, with one of our speakers being a celebrity with an impressive military background as a Navy SEAL, FBI Agent, Federal Air Marshal, and DHS security contractor/advisor, with many appearances on Fox News, CNN, and many other networks. Our national anthem singer is an east coast legend, having performed with Stevie Wonder & Bruce Springsteen. He is also the first double amputee Eagle Scout, a representative of George H. W. Bush's a thousand "Points of Light", and no stranger to singing the national anthem at packed venues for the NBA and NHL.

Saigon Broadcasting Television Network, the first Vietnamese 24/7 TV channel in the US with affiliates all over the globe, will be sending a crew up from Washington, DC, to cover our event. We are working with our township's officials and police force to aid with parking and traffic control in anticipation of a large turn-out.
